Call to Order - Pursuant to the Public Notice dated May 11, 2018, the Public Meeting of the Arizona State Lottery Commission was called to order at 10:01 a.m. by Chair Jeff Weintraub. A quorum was present.

Chair Weintraub entertained a motion to approve the minutes of the April 20, 2018 public meeting; Commissioner Andy Anderson moved; Commissioner Debra Roth seconded. All members voting aye, the motion carried.

Chair Weintraub entertained a motion to approve changing the order of the agenda. The motion was to start with New Business Items and follow up with the Agency Reports. Commissioner Andy Anderson moved; Commissioner Debra Roth seconded. All members voting aye, the motion carried.

New Business – Chair Weintraub asked if any members of the public wanted to address the Commission regarding instant scratch game profiles: *Lucha Libre Loot #1176*, *Alice Cooper #1186* and *\$215 Million Cash Explosion # 1190*. No response from the public.

In accordance with A.R.S. §5-554 (C), Chair Weintraub entertained a motion to approve the order and authorize the Director to issue the order regarding the new instant scratch game profiles: #1176, #1186 and #1190. Commissioner Anderson moved; Commissioner Roth seconded. All members voting aye, the motion carried.

Chair Weintraub asked if any members of the public wanted to address the Commission regarding new promotion profile *Bingo and Crossword 2nd Chance Promotion profile #88*. No response from the public.

In accordance with A.R.S. §5-554 (C), Chair Weintraub entertained a motion to approve the order and authorize the Director to issue the order regarding second chance promotion profile

Bingo and Crossword 2nd Chance Promotion profile #88. Commissioner Anderson moved; Commissioner Roth seconded. All members voting aye, the motion carried.

Chair Weintraub asked if any members of the public wanted to address the Commission regarding Fast Play Game Profiles: *\$20 on the Spot #108, and Hot Numbers #109*.

In accordance with A.R.S. §5-554 (C), Chair Weintraub entertained a motion to approve the order and authorize the Director to issue the order regarding Fast Play game profiles #108 and #109. Commissioner Roth moved; Commissioner Anderson seconded. All members voting aye, the motion carried.

Director's Report – Director Edgar presented slides and a short video from Young Entrepreneur Academy. Director Edgar advised that Keno was denied by legislation. Director Edgar advised sports betting was approved by the Supreme Court on May 14, 2018. Commissioner Anderson inquired: “If the Lottery handles sports betting will the Arizona Lottery hire more personnel? Director Edgar advised 70% of the world’s sport betting is handled through lottery and yes, the Arizona Lottery would have to hire more personnel. The Arizona Lottery would look into the matter when the time arises. The presentation is attached for the official minutes.

Financial Report – Arizona Lottery Chief Financial Officer, Mr. Biju Kamaleswaran presented fiscal year-to-date financial information. The presentation is attached for the official minutes.

Marketing Report – Arizona Lottery Deputy Director of Products and Marketing, Chris Rogers presented information on the FY19 Marketing Plan, Objective and Goals. The presentation is attached for the official minutes.

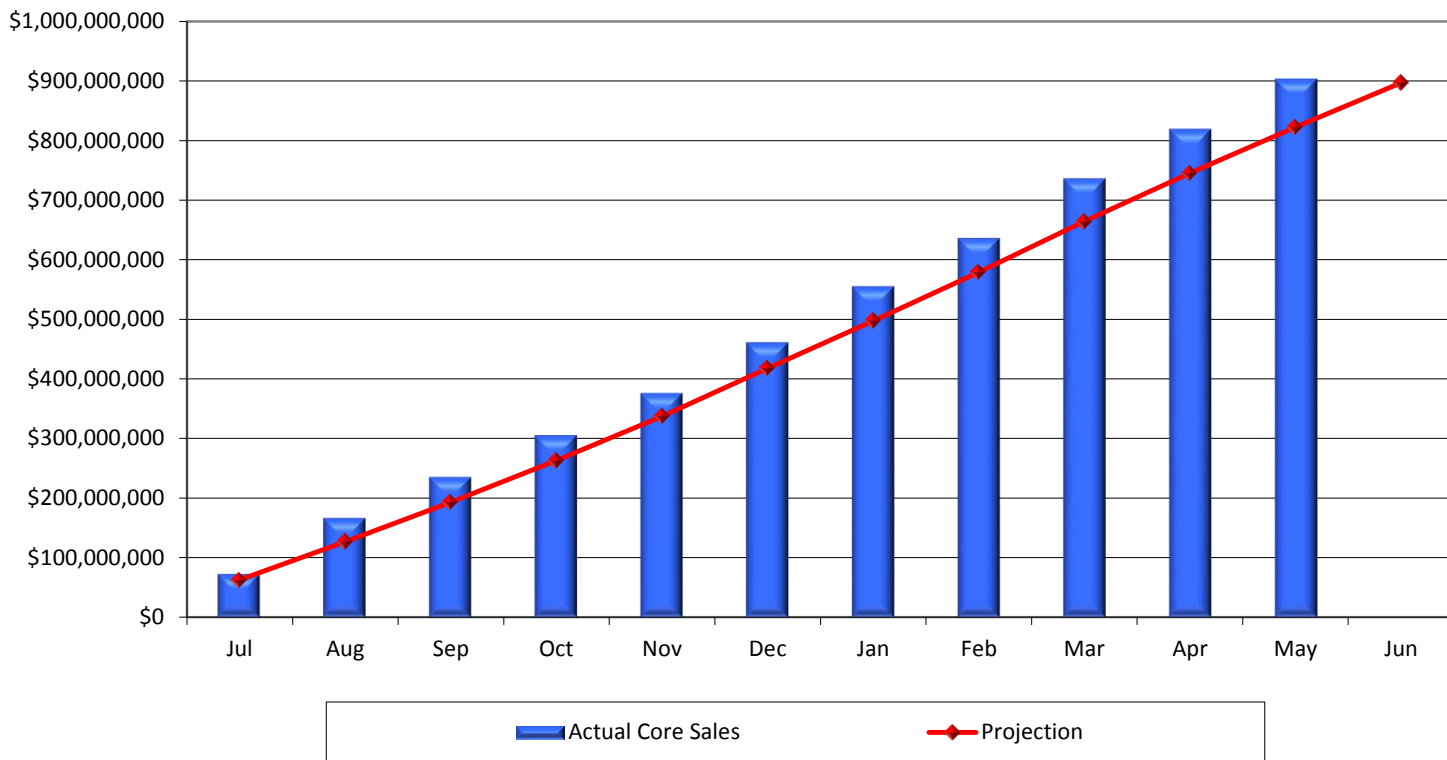

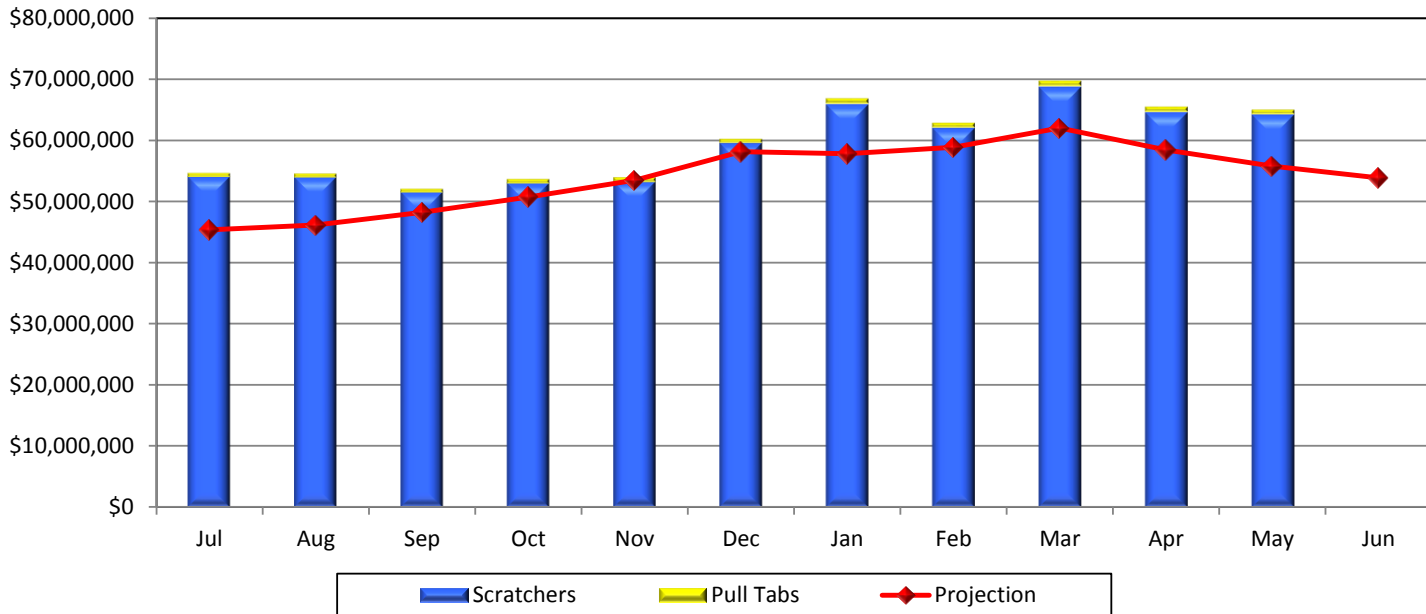

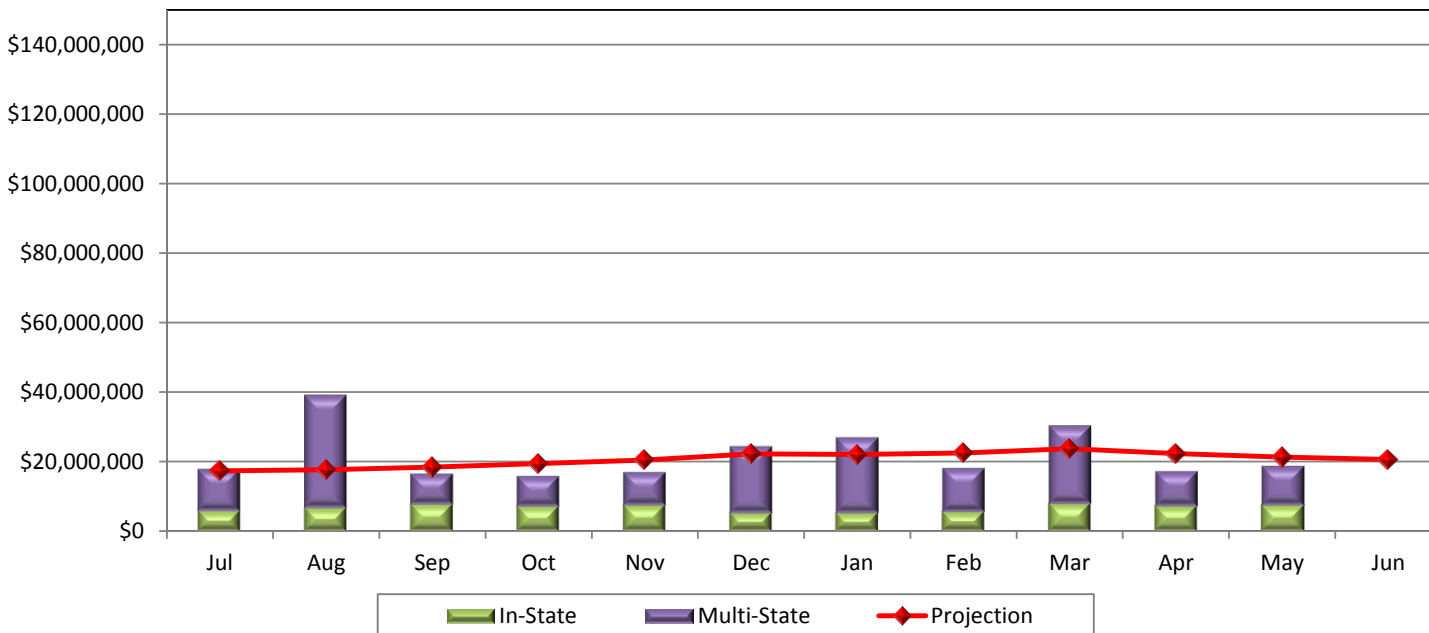

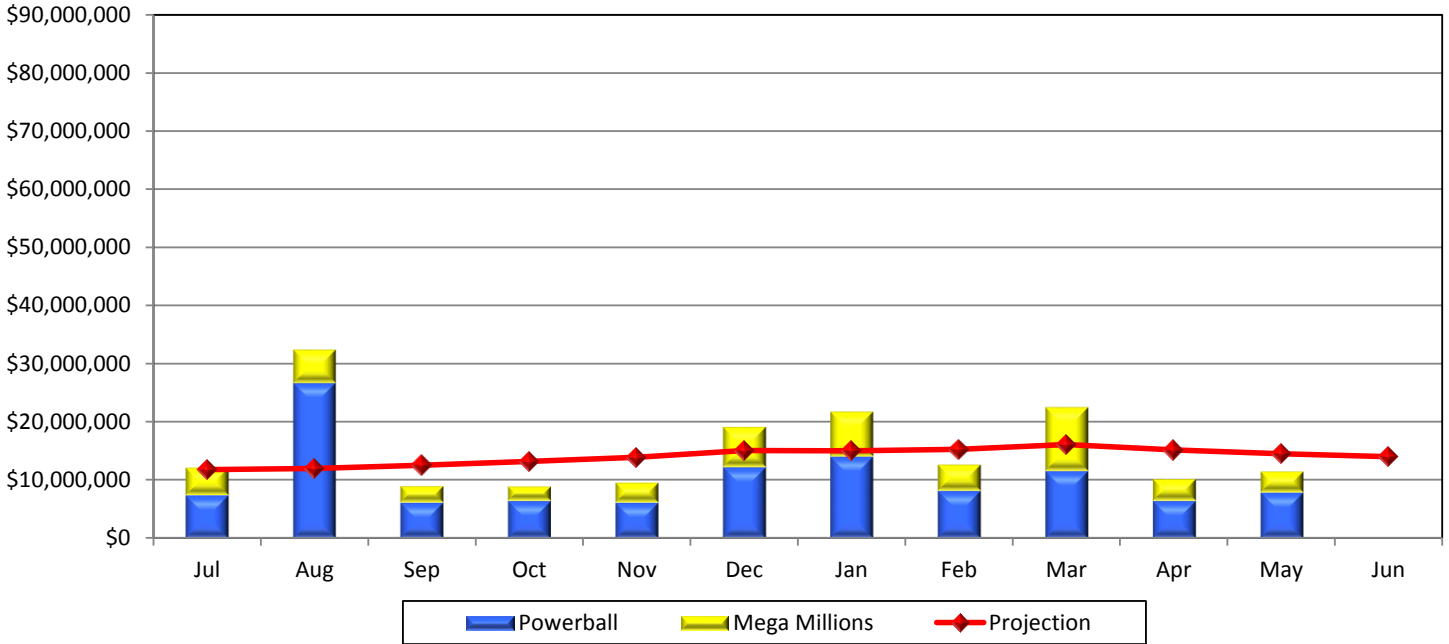
Total Draw Games

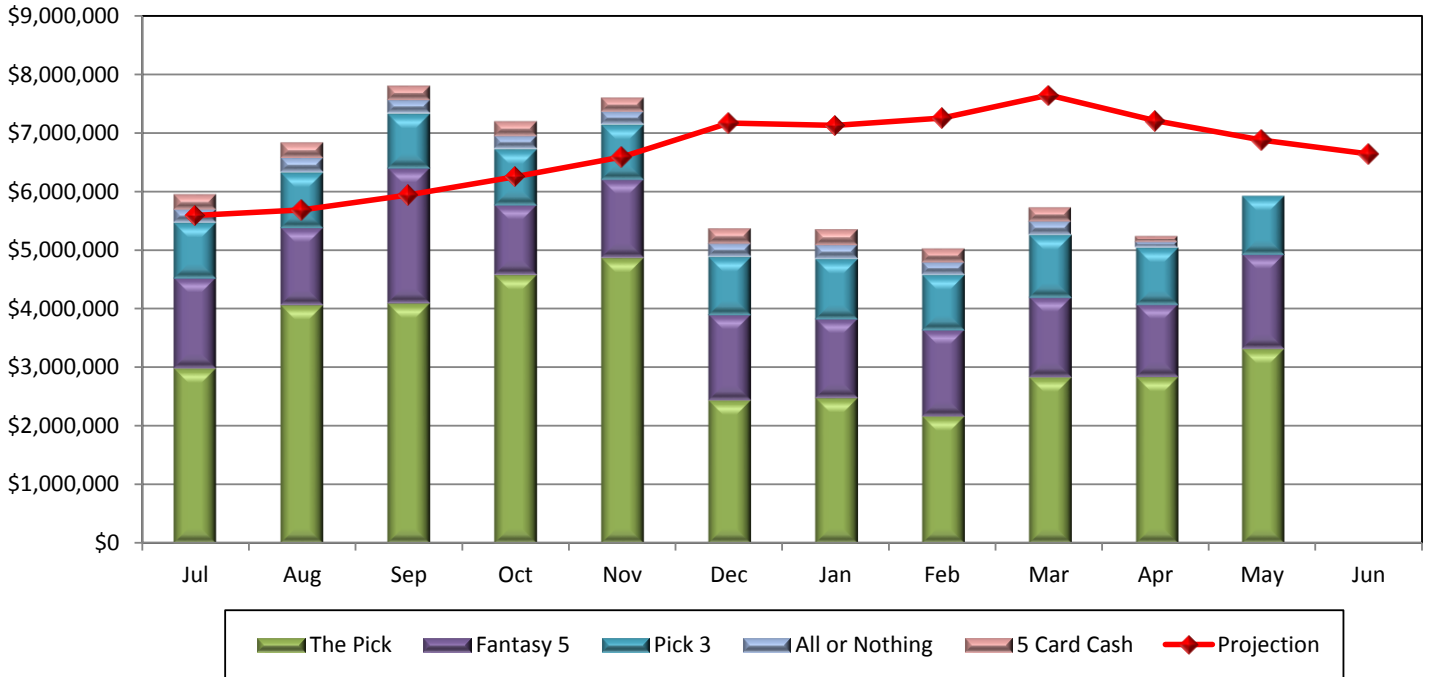

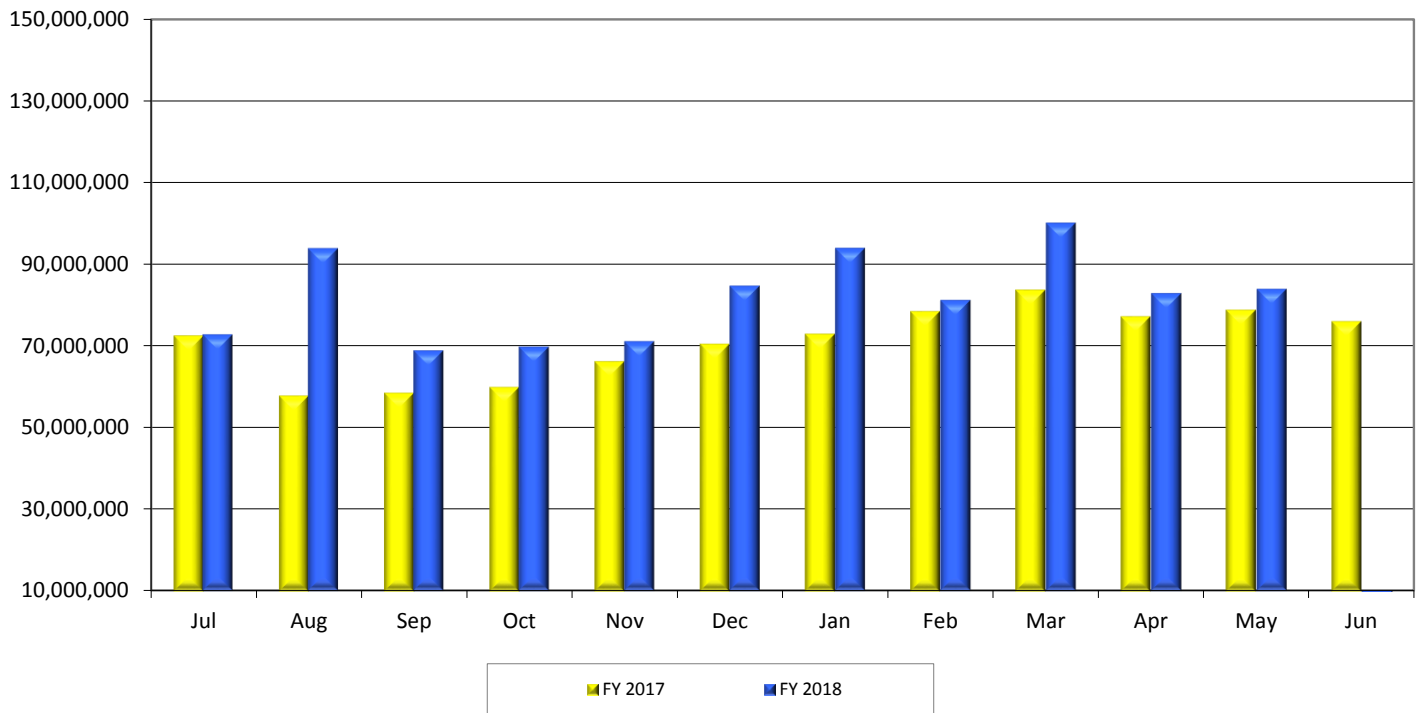

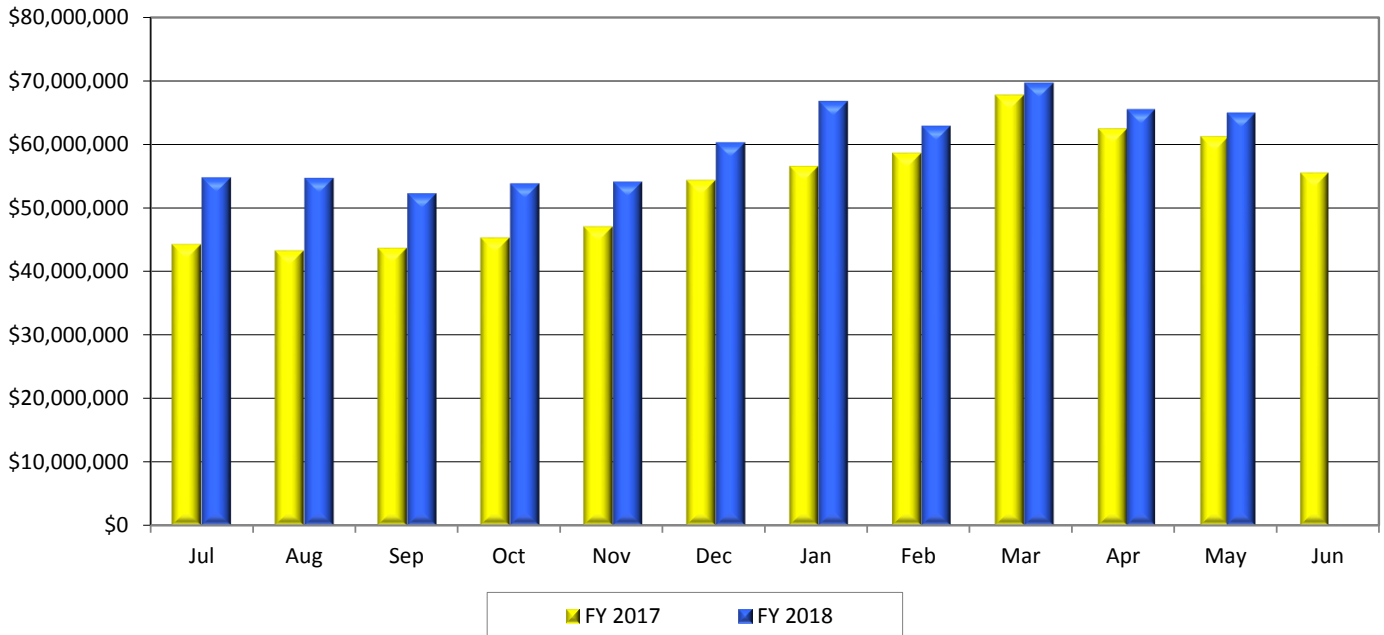

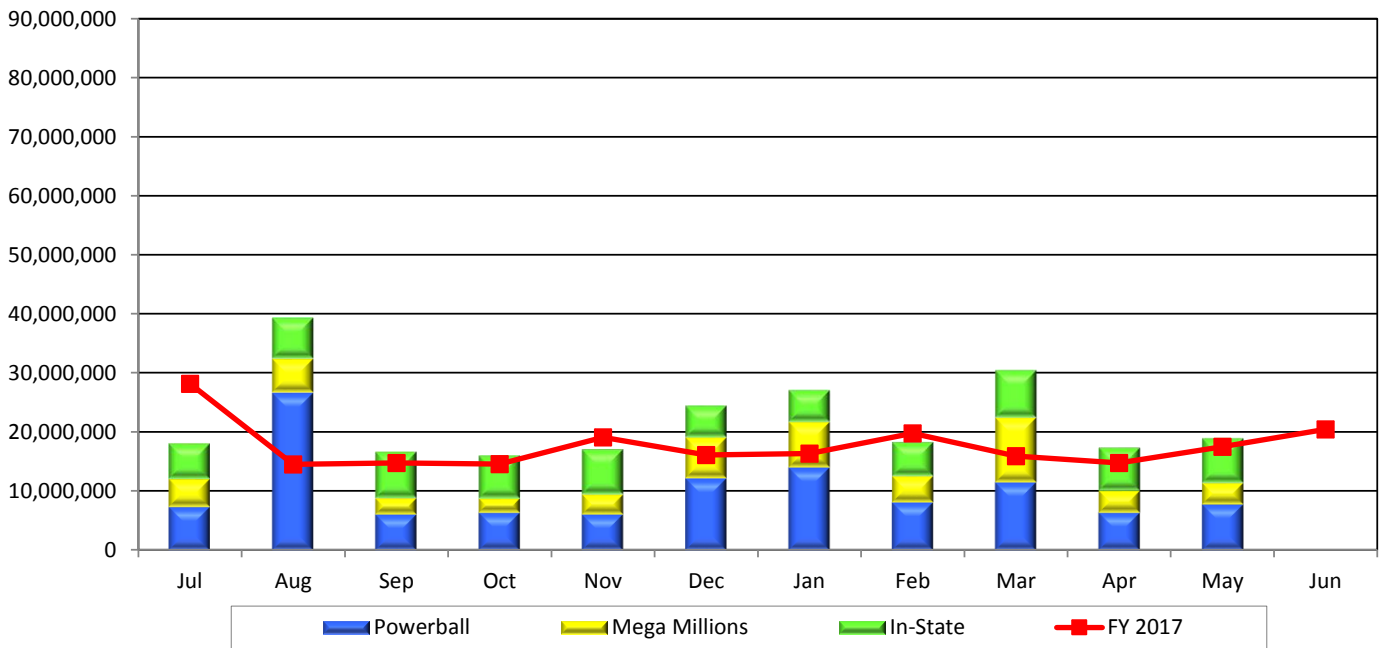

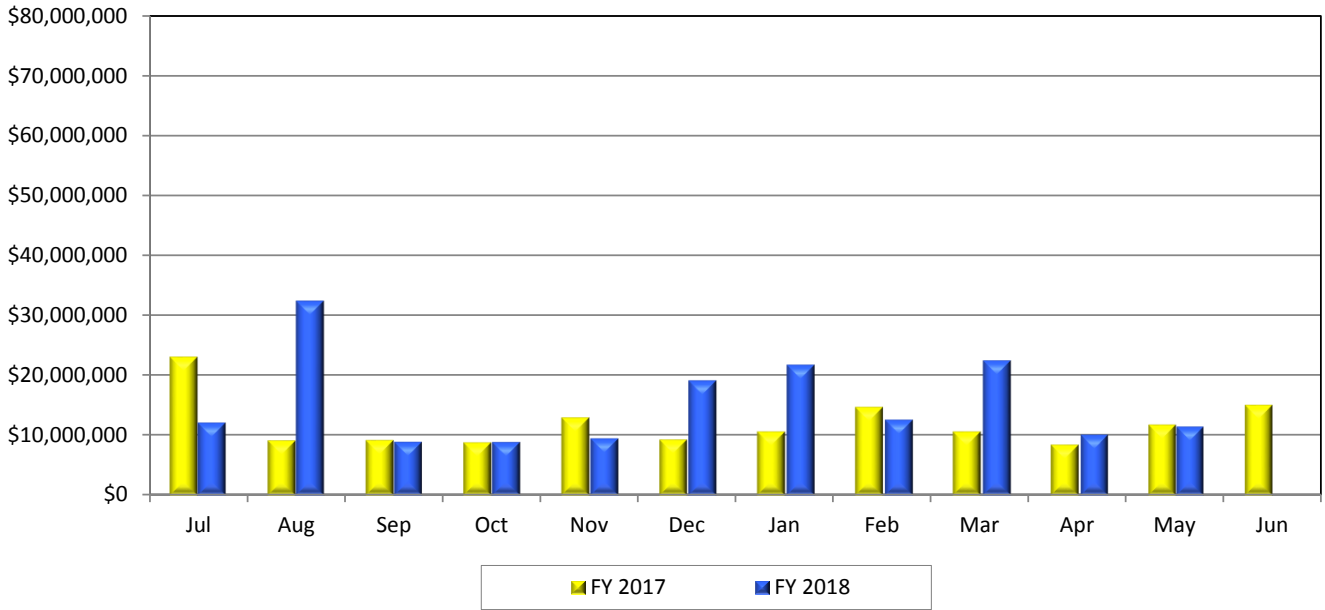
Total Draw Games

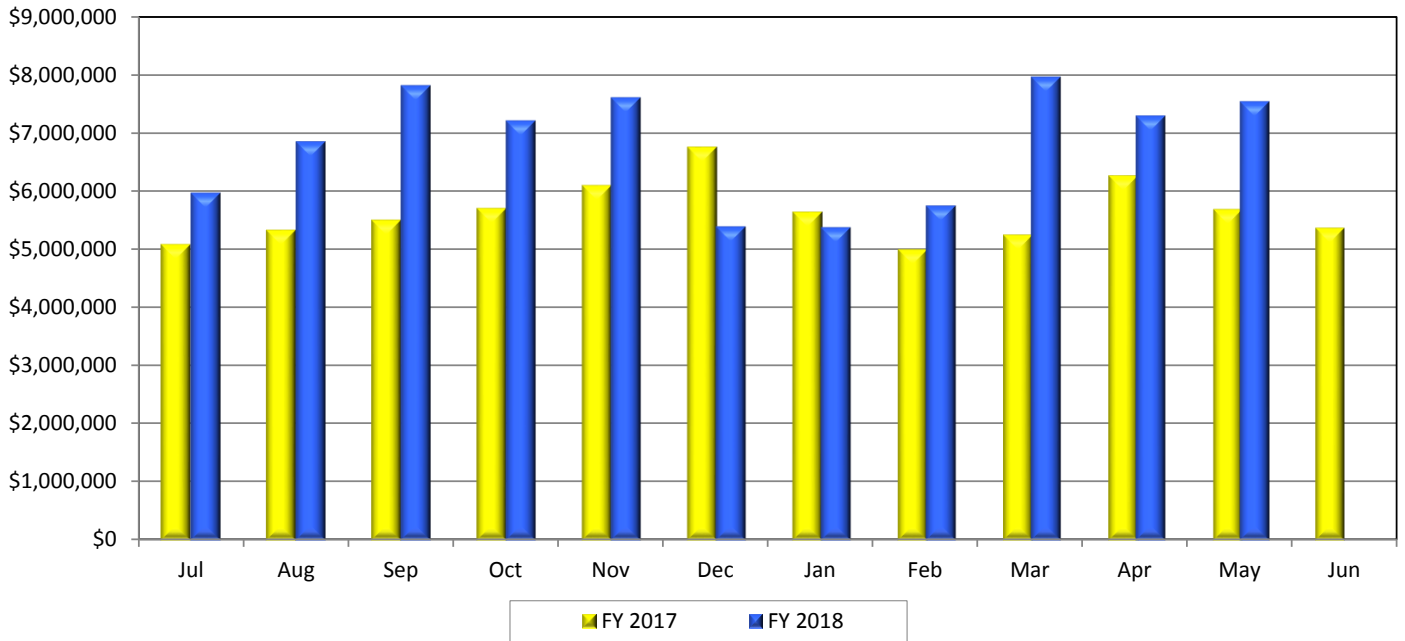

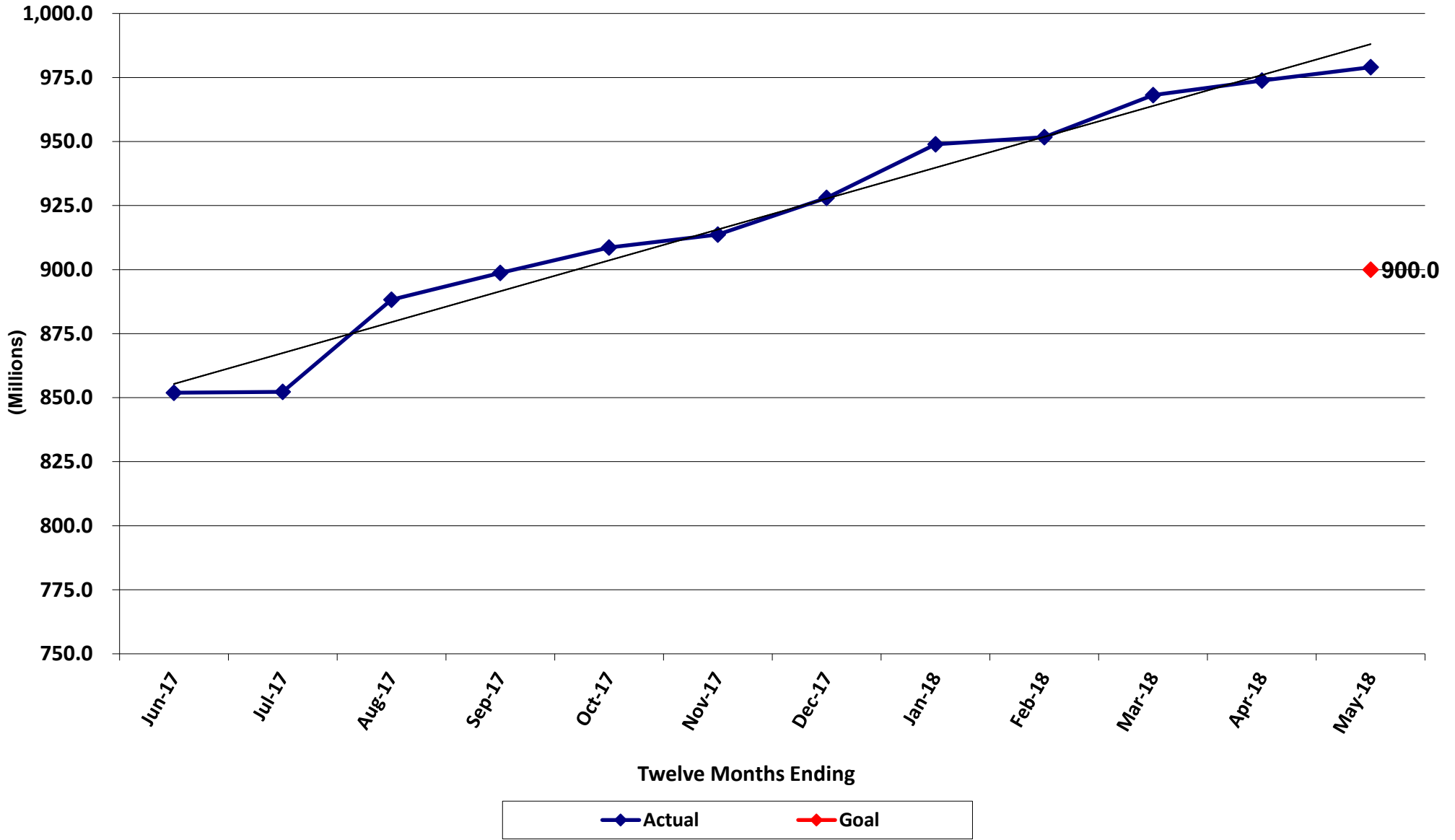

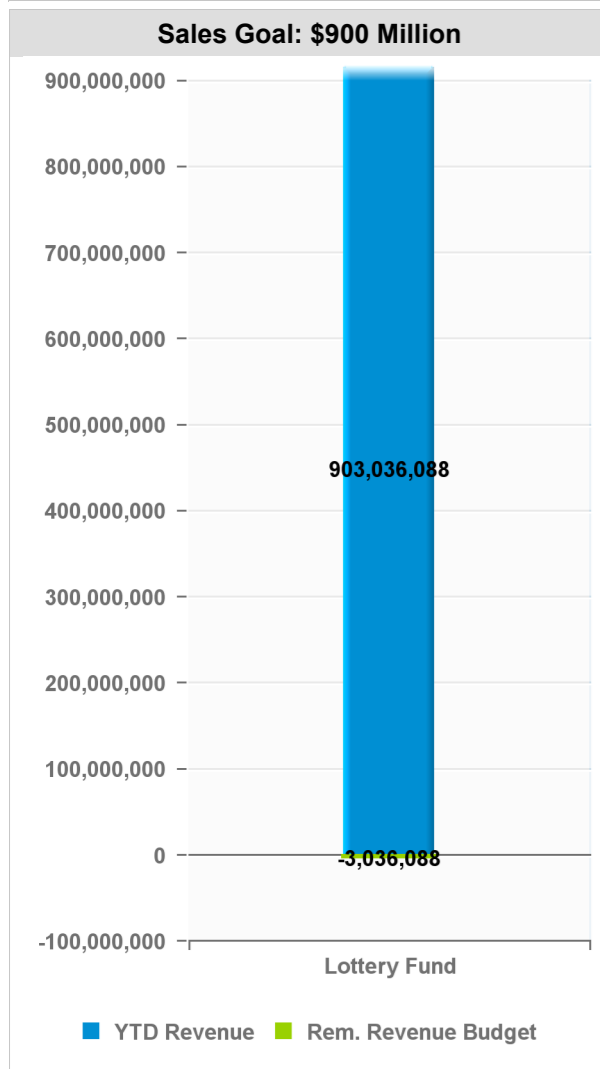

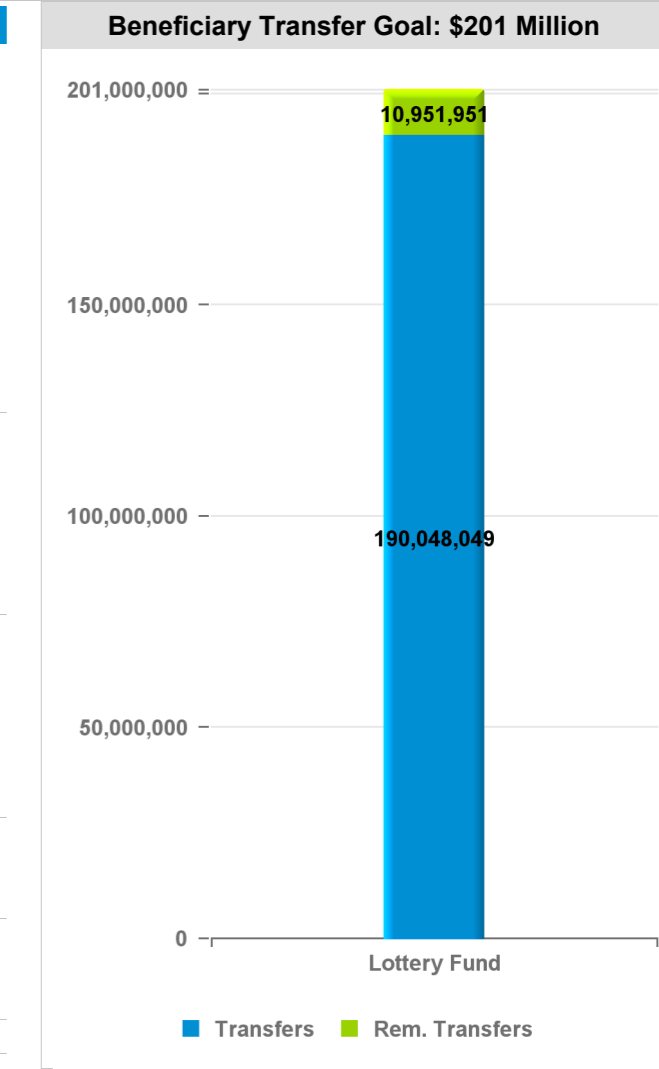

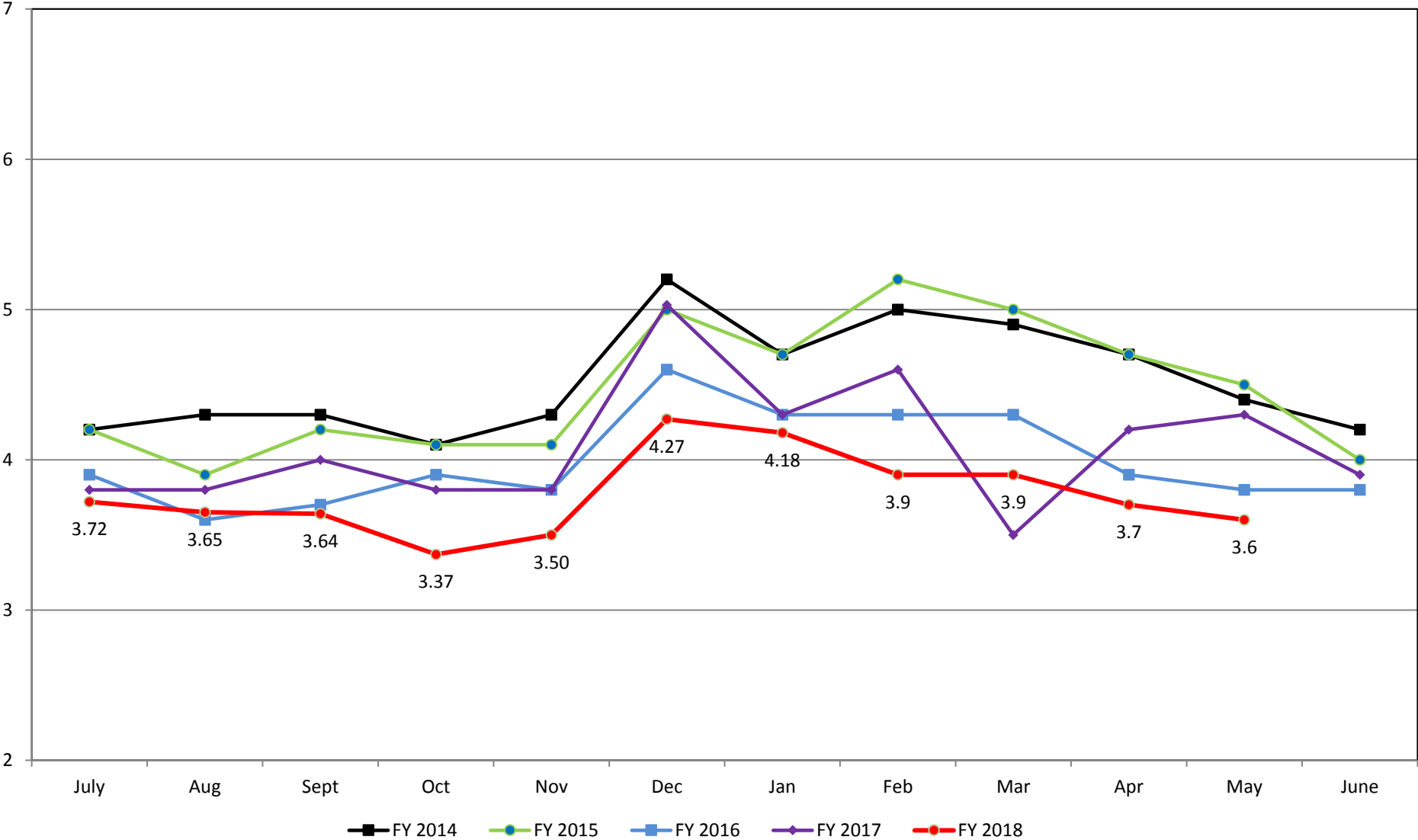
Budget by Appropriation Type and Object Class



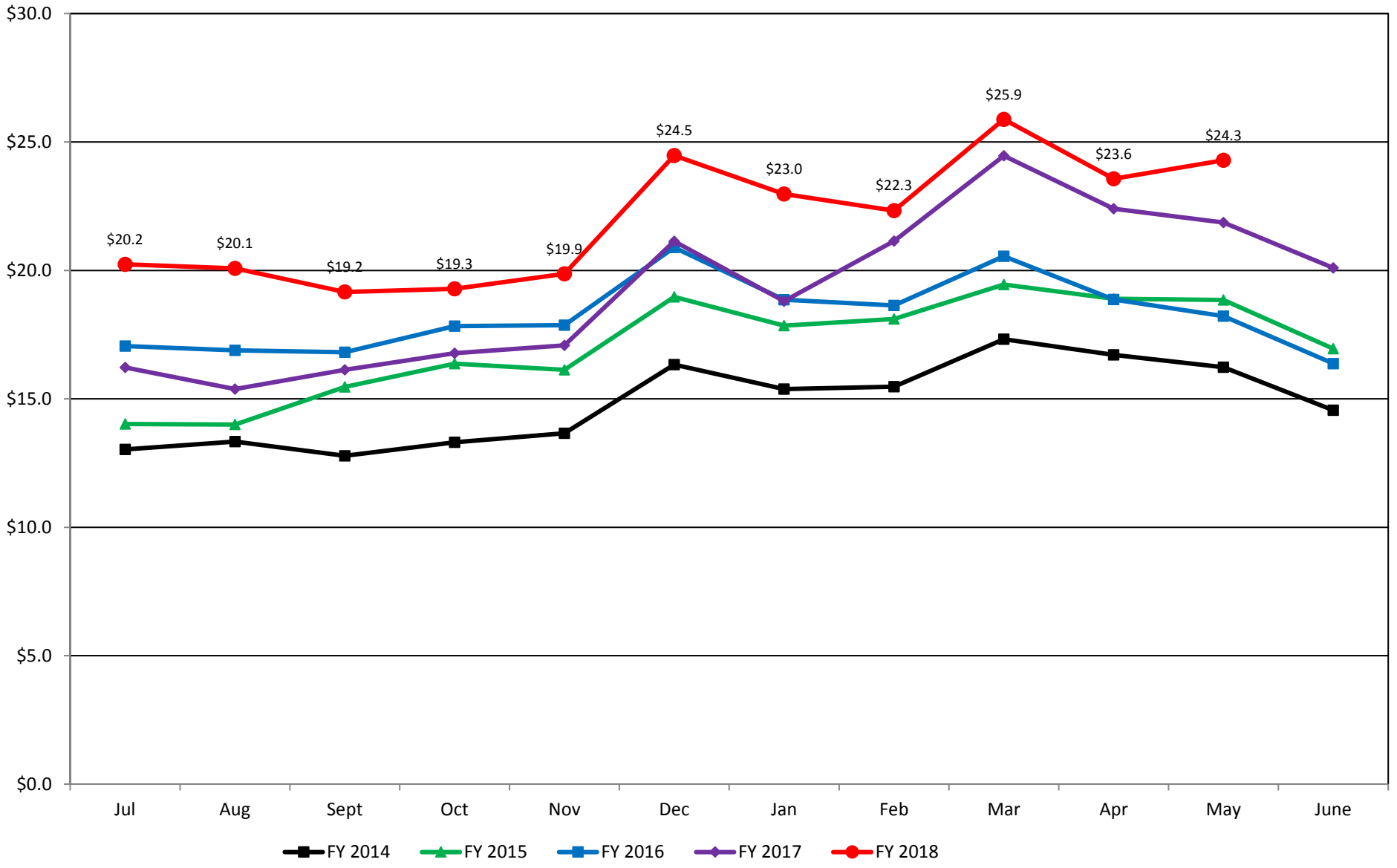

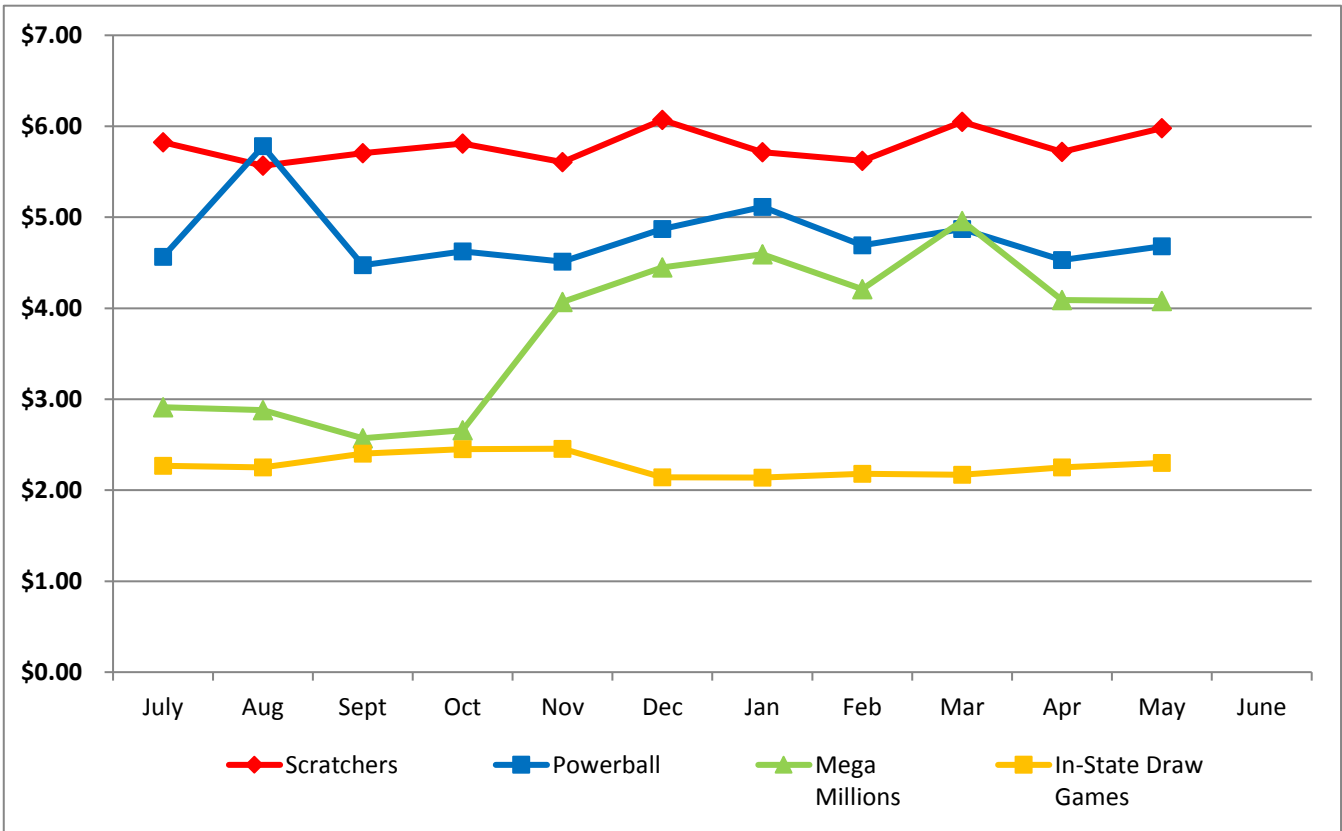

This report has been provided to the Lottery Commission regarding instant scratch game profiles planned for Arizona Lottery instant scratch games. The Commission is requested to approve these game profiles. After Commission approval, staff will commence with plans for printing, distribution, and sales of these games.

NEW GAME PROFILES

Attached for the Lottery Commission's action are new instant scratch game profiles: *Reindeer Series* #1178, *Holiday Cash Drop* #1179, *Christmas Crossword* #1180, *Holiday 7* #1181, *Money Tree* #1182, *White Ice 7s* #1183, *\$100,000 Holiday Countdown* #1184, *Green Line Slingo[®] Trio* #1185, *\$100,000 Crossword* #1187, *Fruit Explosion* #1188, *Magic Number Bingo* #1189, and *\$250,000 Crossword* #1191.

Reindeer Series #1178. This \$1 game has a top prize of \$500 and will be printed at a quantity of approximately 3.1 million tickets.

Holiday Cash Drop #1179. This \$2 game has a top prize of \$10,000 and will be printed at a quantity of approximately 2 million tickets.

Christmas Crossword #1180. This \$3 game has a top prize of \$20,000 and will be printed at a quantity of approximately 1.9 million tickets.

Holiday 7 #1181. This \$5 game has a top prize of \$50,000 and will be printed at a quantity of approximately 1.9 million tickets.

Money Tree #1182. This \$10 game has a top prize of \$100,000 and will be printed at a quantity of approximately 1.4 million tickets.

White Ice 7s #1183. This \$20 game has a top prize of \$500,000 and will be printed at a quantity of approximately 1.4 million tickets.

\$100,000 Holiday Countdown #1184. This \$10 game has a top prize of \$100,000 and will be printed at a quantity of approximately 1.2 million tickets.

Green Line Slingo[®] Trio #1185. This \$5 game has a top prize of \$50,000 and will be printed at a quantity of approximately 2.6 million tickets.
