<u>Call to Order</u> - Pursuant to the Public Notice dated April 15, 2019, the Public Meeting of the Arizona State Lottery Commission was called to order at 10:00 a.m. by Chair Jeff Weintraub. A quorum was present.

Chair Weintraub entertained a motion to approve the minutes of the March 22, 2019 public meeting; Commissioner Roth moved; Commissioner Crum seconded. The vote was unanimous with all members voting aye and the motion was carried.

<u>Retailer of the Quarter</u> – Mr. Wyeth Hines gave a PowerPoint presentation highlighting Fry's Marketplace #657 located at 35401 N. Lake Pleasant Parkway, Peoria, AZ. The presentation is attached for the official minutes.

<u>Director's Presentation</u> – Mr. Chris Rogers presented slides and a short video on the beneficiary of the month "Strangers We Know," a non-profit organization assisting trauma stricken children who are removed from homes. Mr. Rogers gave a recap of the ADDY Awards received. Owens Harkey (OH) Representative Ms. Chelsea Smeland explained the ADDY Awards are the advertising industry's largest and most representative local competition. Chair Weintraub wanted to know what the criteria is to win an award. Mr. Rogers informed the Commission that it is a collaborative effort with the Arizona Lottery and the marketing firm OH. Chair Weintraub also inquired if the awards are based on creativity. Mr. Rogers yes.

Mr. Rogers continued with the presentation and gave an overview of the Powerball® Dick Clark Productions New Year's Rockin' Eve live drawing and the upcoming North American Association of State and Provincial Lotteries (NASPL) Conference. Mr. Rogers informed the Commission that Arizona will be hosting the NASPL Conference in July. Chair Weintraub informed Mr. Rogers that he was interested in attending and encouraged the other Commissioners to attend. The presentation is attached for the official minutes.

<u>Financial Report</u> – Mr. Biju Kamaleswaran presented a financial overview of sales from all product lines for the past 12 months as well as year-to-date sales. The presentation also included budget information. The presentation is attached for the official minutes.

<u>Marketing Presentation</u> - Ms. Shelby Alessi gave a marketing PowerPoint presentation highlighting the Players Club Second Chance and the FY18 Million Dollar Madness vs. F19 Million Dollar Giveaway. The presentation is attached for the official minutes.

Ms. Ivy Gilio clarified that game #121 should be One Arm Bandit and not I Arm Bandit #121. 






# YTD Sales vs. Projection




# FY 2019 Total Sales vs. Projection



# **Rolling 12 Month Total Sales**






# Total Sales FY 2018 vs. 2019 vs. Projection






# Draw Sales FY 2018 vs. 2019 vs. Projection






# Instant Sales FY 2018 vs. 2019 vs. Projection



# **Draw Sales by Month**







### **NEW GAME PROFILES**

Attached for the Lottery Commission's action are new instant scratch game profiles: *The Addams Family*<sup>©</sup> *Fortune* #1227, *Hit It Big* #1233, *Fa La La* #1237, *Stocking Stuffer* #1238, *Jolly Holiday Crossword* #1239, *Holiday* 7 #1240 and 25 Days of Winning #1241.

**The Addams Family** Fortune #1227. This \$2 game has a top prize of \$10,000 and will be printed at a quantity of approximately 1.4 million tickets.

*Hit It Big #1233.* This \$10 game has a top prize of \$100,000 and will be printed at a quantity of approximately 1.6 million tickets.

<u>Fa La La #1237.</u> This \$1 game has a top prize of \$500 and will be printed at a quantity of approximately 3.1 million tickets.

<u>Stocking Stuffer #1238.</u> This \$2 game has a top prize of \$10,000 and will be printed at a quantity of approximately 2 million tickets.

<u>Jolly Holiday Crossword #1239.</u> This \$3 game has a top prize of \$20,000 and will be printed at a quantity of approximately 2 million tickets.

*Holiday 7 #1240.* This \$5 game has a top prize of \$50,000 and will be printed at a quantity of approximately 1.9 million tickets.

<u>25 Days of Winning #1241.</u> This \$10 game has a top prize of \$100,000 and will be printed at a quantity of approximately 1.4 million tickets.

### **NEW 2<sup>nd</sup> CHANCE PROMOTION PROFILES**

Attached for the Lottery Commission's action are new Promotion Profiles: *Powerball® New Year's Rockin' Eve 2<sup>nd</sup> Chance Promotion #95* and *Beat the Heat Promotion 2nd Chance #96*.

## Powerball® New Year's Rockin' Eve 2nd Chance Promotion #95

On July 29, 2019, the Arizona Lottery will introduce a Powerball promotion, where players may enter winning or non-winning Powerball tickets for a chance to win a "New Year's Rockin' Eve VIP Experience" for two and a chance to win \$1 Million. The promotion will run through September 8, 2019. Following this date, one drawing will be held, producing 25 winners.

### Beat the Heat 2<sup>nd</sup> Chance Promotion #96

Starting July 1, 2019, players will be able to enter non-winning tickets from designated instant scratch ticket and Fast Play games for a chance to win weekly cash prizes.

#### **New Business Item #3**

Game Profile Amendments Report to Arizona Lottery Commission May 17, 2019

This report has been provided to the Lottery Commission regarding on-line game profiles planned for Arizona Lottery on-line games. The Commission is requested to approve the attached game profiles. After Commission approval, staff will commence with plans for game development, launch and subsequent sales of the game listed below.

#### AMENDED GAME PROFILES

Attached for the Lottery Commission's action are three amended on-line game profiles as follows: *Triple Twist, Fantasy 5* and *Pick 3*.

<u>Triple Twist.</u> This \$2 on-line game includes a jackpot starting at \$200,000. A total of three lines of six numbers, each from a 42-number matrix, are selected as a game play. A player can win up to four times on a single ticket by matching 3, 4, 5, or 6 of the numbers drawn in any order, on a single line, or five or more on all three lines combined.
