

Arizona Lottery 2020 Country MegaTicket® Giveaway Official Interim Rules

Eligibility

The Arizona Lottery 2020 MegaTicket Giveaway (the "Promotion"), presented by the Arizona Lottery, is open only to those individuals who are persons age twenty-one (21) or older on the date of entry. The following individuals are not eligible to participate or win a prize in this Promotion: an employee or officer (or any spouse, child, sibling, or parent residing as a member of the primary household of such employee or officer) of Owens Harkey & Associates, LLC ("OH"), the Arizona Lottery ("Lottery" or "Sponsor"), Live Nation Marketing Inc. ("Live Nation"), Circle K Stores ("Circle K"), and each of their respective parents, affiliated companies, subsidiaries, licensees, vendors, distributors, dealers, retailers, agents, printers, sponsors of the Promotion, advertising and promotion agencies and any and all other companies if they are associated with the Promotion (collectively, the "Parties").

Entry/How to Play

To enter, a player must purchase any one (1) ten-dollar (\$10) Scratchers® ticket in a single transaction at the counter of participating Circle K stores ("Qualified Purchase") and use the Circle K Lift Tool to enter their phone number while making a Qualified Purchase.

For each Qualifying Purchase, subject to limitations, the Qualifying Purchaser will receive one (1) entry into the Grand Prize Drawing

Limitations

Purchases made at the vending machine or at non-participating retail locations will not be valid for the promotion.

There is no limit on the number of ten-dollar (\$10) Scratchers tickets that may be purchased in a transaction, but there is a limit of one (1) entry per transaction.

This is a non-cash prize; players who owe debts to the State of Arizona will be disqualified from winning any prize worth more than \$600.

Retail Event Location

The Promotion date, time and location are as follow:

 - Friday, September 18: Jason Aldean with Mitchell Tenpenny and Dee Jay Silver
 - Saturday, October 10: Rascal Flatts Farewell Tour with special guests

- Premiere Parking Voucher for each show (One voucher per 2 tickets purchased)
The value of each Grand Prize is \$1,398.00.

Selection of concert seat location is solely within Live Nation's discretion. Travel and accommodations are not included and are the sole responsibility of winner and guest. Winner and guest must abide by all venue policies. Sponsor and/or Live Nation reserves the right to revoke full or partial prize from any winner or winner's guest who it and/or venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, and/or may bring Sponsor and/or Live Nation into disrepute. Resale of tickets is prohibited.

Taxes and Expenses

The Winners are responsible for any local, state and federal taxes. Any additional expenses incident to any prize are the responsibility of the winners; for example, travel, food, and beverages related to the Promotion or the Grand Prize are not included. Sponsor will issue a 1099 to the Winners for tax purposes.

Odds of Winning

Odds of winning a prize are based on the number of entries a player receives and the total number of entries received in the drawing.

Claiming Requirements

. Prizewinners must claim their prize within seven (7) calendar days from the prizewinner notification date by the Sponsor. If all reasonable efforts to locate a prizewinner fail within the seven (7) calendar-day period, the Lottery may select a replacement winner as previously described.

A.R.S. § 5-573 requires winners of a prize valued at \$600 or more to be reviewed for potential debts owed to certain State of Arizona entities. In such case, established procedures will be followed. Winners must provide their correct name and address. For prizes of \$600 or more, winners must complete a Winner Claim Form and provide a form of government-issued photo identification and pass all validation checks prior to claiming their prize.

Disqualification, forfeiture, and the selection of an alternate potential winner may result from any of the following: (a) the potential winner's failure to respond to any notification within the specified response period; (b) the return of an email notification as undeliverable after three (3) attempts; (c) the return of any other notice as undeliverable; (d) the potential winner's failure to provide satisfactory proof of age, identity, and residency; (e) the potential winner's failure to execute and return the required documents (including, without limitation, the Winner Claim Form) within the specified return period; (f) the potential winner's failure to be available to receive the prize; (g) the potential winner's failure to validly claim the prize by the date specified in the prizewinner notification; (h) debts owed to the State of Arizona, or (i) any other non-compliance with the law, these Official Rules, the Terms of Use, or the Privacy Policy. In the event of a forfeiture of the prize, the Lottery may, in its sole discretion, award or not award the forfeited prize to an alternate winner.

General Terms:

By providing a mobile number, a participant consents to receiving marketing messages via automated technology from Circle K to the mobile number provided and understands consent is not a condition of purchase. Consent applies to all Circle K text message programs in which the participant enrolls.

By participating in this Promotion, entrants agree to be bound by these Official Rules. All entrants and winners are solely responsible for the actions of any guests who accompany them to a Grand Prize concert. Entrants without proper address and those who have opted not to be contacted by the Parties for any reason will be excluded from drawings. No prize substitution, cash equivalent, or transfer of prize by any winner in violation of these rules and regulations is permitted. The Parties reserve the right to substitute prizes of equal or greater value.

The Arizona Lottery 2020 Country MegaTicket Giveaway and conditions of the Promotion are approved by order of the Arizona Lottery Commission pursuant to A.R.S. § 5-554(C) and Arizona Lottery Promotion Profile # 54, "Buy X and Get Y Free - Player" Play Style. Should any winner make any false statement in connection with this Promotion, the winner will be required to promptly return to the Parties, upon demand, any prize.

The Parties reserve the right, in their sole discretion, to modify these Official Rules without materially affecting the terms and conditions of the Promotion. No modification or amplification, oral or written, with respect to the covenants, conditions and terms herein contained, shall be binding upon the Parties unless embodied in an instrument in writing mutually approved by the Parties. The Parties reserve the right to modify, terminate, or suspend the Promotion, or any part of it, if any viruses, bugs, unauthorized human intervention, fire, flood, earthquake, epidemic, explosion, labor dispute or strike, act of public enemy, equipment failure, riot or civil disturbance, war or other military action, terrorist threat or activity, government order, fraud, technical failures or any other factor beyond the Parties' reasonable control (a "Force Majeure Event") impairs the integrity, feasibility or proper functioning of the Promotion, as determined by the Parties in their sole discretion. The Parties reserve the right, in their sole discretion, to disqualify any entrant, winner or designee from participating in any aspect of the Promotion if they deem or suspect that such person has engaged in or has attempted to engage in any of the following: (a) acting in violation of the law or these Official Rules; (b) damaging or tampering with or corrupting the entry process or the operation of the Promotion; (c) participating in unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent or potentially fraudulent behavior; (d) acting with intent to annoy, abuse, threaten or harass any other person; or (e) participating in any activity deemed to be generally inconsistent with the intended operation of the Promotion. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, the Parties reserve the right to seek damages from any such person to the fullest extent permitted by law. The Parties' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Whether caused by an entrant, by any of the equipment or programming associated with or utilized in a Promotion, or by any technical or human error that may occur in the processing of the Promotion, the Parties are not responsible for inaccurate Promotion information arising from any cause. The Parties are not responsible for any printing or technical error which may occur in processing, printing or distribution of Promotion materials.

The Parties make no express or implied warranties, guaranty or representation of any kind that any Lottery tickets that are purchased or won will be winning Lottery tickets or with respect to the safety, appearance, or performance of any prize offered.

By participating in the Promotion, each winner hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the Parties' use of winner's name, address (city and state of residence), photograph, voice, statement and/or other likeness and prize information for advertising, promotional, trade and/or any other purpose in any and all media or format now known or hereafter devised, throughout the world, in perpetuity, unless prohibited by law.

Limitation of Liability

By accepting a prize, an entrant, on behalf of himself or herself and his or her heirs and legal representatives, agrees to release Live Nation Worldwide, Inc., ("Live Nation") the all Parties from, and shall hold the Live Nation, all Parties harmless against, any liability, loss, claims, injury or damage to property or to person, including death, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prizes or participation in this Promotion, even if caused or contributed to by the negligence of the Live Nation and all Parties. Live Nation and Parties are not liable in the event that any portion of the Promotion or prize is canceled due to any Force Majeure Event. This Limitation of Liability shall expand and not replace the limitation of liability terms on the back of the Game ticket.

Disputes

Any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded are governed by Arizona Administrative Code (“A.A.C.”) § R19-3-1008. The decision of the Parties is final. Any decision by the Arizona Lottery Director is a final, appealable agency action to the Office of Administrative Hearings under the procedures of A.A.C. § R2-19-101 through § R2-19-122. Exhaustion of administrative remedies applies.

Live Nation is not a sponsor of the Promotion and is no way responsible for the administration of the Promotion and the verification of winners. All inquiries regarding the Promotion should be directed to Arizona Lottery
