Oral Proceeding for Arizona Lottery Rulemaking (Article 11) on Lottery Courier Services.

6. Summary of the Rules: Article 11 establishes a regulatory framework for lottery courier services, defining terms and outlining authorization requirements. It prohibits unauthorized operations, with potential disciplinary action for non-compliance. The Director of the Arizona Lottery has discretion to manage the program.
7. Proposed rules will be submitted to the Governor's Regulatory Review Counsel for approval/rejection within 120 days.
