

- 1. Sign the back of your ticket.
- 2. Complete and deliver the following form, together with the original winning ticket and your government-issued ID to either of the following **Arizona Lottery** locations:

Or mail your ticket, claim form, and a copy of your government-issued ID to the Arizona Lottery at:

- 3. In this form, a "Related Person" is defined as persons who are directly employed by the Arizona lottery or persons (e.g., spouse, children, parents, siblings, housemates, roommates, friends and/or romantic partners) whose principal residence is the same as such lottery employee are prohibited from participation. Additionally, any vendors/contractors responsible for supplying gaming equipment or lottery tickets, advertising, consulting services, participates in any way with the drawings or otherwise selecting winning lottery tickets or who have access to secured Arizona Lottery Locations or those (see above) whose principal residence is the same as such vendors or contractors or the immediate supervisors of such vendors or contractors are prohibited from participation.

- I understand that, under A.R.S. § 5-573(C), my prize information will be reported by my social security number to the Arizona Department of Economic Security and that my prize may be used to offset any child support or State of Arizona debt owed by me; and
- I understand that my taxpayer ID must be provided for tax reporting purposes under 26 U.S.C. § 6109; and I have provided my correct name, address and taxpayer ID number, as the recipient of this prize.
